The Thailand Greenhouse Gas Management Organization (Public Organization): TGO has received financing from the World Bank toward the cost of the Partnership for Market Readiness (PMR), and intends to apply part of the proceeds for consulting services.

Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the *Selection Based on the Consultants' Qualifications (CQS)* method set out in the Consultant Guidelines.
